Patricia Jane Hamilton Beacon Creator

While the goals of MARSP to ensure fair pensions and insurance did not impact her, she continued to be an advocate for children and teachers through KARSP. Her influence and friendship will be missed.



Legislative Update

Filling A Need, Taking Action

MARSP supported House Bill 4752 recently signed into law by Governor Whitmer. It allows public school retirees to go back to work within six months of retirement, provided their earnings in a calendar year did not exceed



\$15,100. Their earnings limit would reset at the end of the year, and 6 months after a retiree's original bona fide retirement date, they would be able to return to employment without any limitations. A caveat was added to the bill in the Senate Education Committee specifically prohibiting retired superintendents from returning to work as superintendents prior to 6 months after retirement.

Michigan Public School Employees' Retirement

MARSP has submitted formal support for HB 5021, a default retirement plan for newly hired employees that will change from the Defined Contribution to the Hybrid Pension Plus plan. Details on how this bill impacts the future of the MPSER plan are explained under the Advocacy tab on the MARSP website.

As a reminder as you prepare for the new tax year, the Office of Retirement Services has released a summary of the new Public Act 4 which makes changes in how much state tax will be withheld from your pension. Like all tax laws it is complex; consult with your tax advisor for personal information if you have questions. This summary covers the first year of the law; for the complete law, visit:

2023 tax year

- For those born in 1945 or before: There is no change. You can still deduct the full amount of the allowable deduction. For the 2023 tax year, it's \$61,518 for single returns and \$123,036 for joint returns.
- Those born between 1946 and 1952: You can choose between the maximum deduction of
 - \$20,000 for single returns and \$40,000 for joint returns (the previous provisions of the Income Tax Act of 1967), or
 - Up to 25% of the maximum amount of the allowable deduction for those born in 1945 or before, which for the 2023 tax year would equal a deduction of \$15,379.50 for a single return and \$30,759 for a joint return.
- Those born between 1953 and 1958 who are
 67 years of age or older: You can choose between the maximum deduction of
 - \$20,000 for single returns and \$40,000 for joint returns (the previous provisions of the Income Tax Act of 1967), or
 - Up to 25% of the maximum amount of the allowable deduction for those born in 1945 or before, which for the 2023 tax year equals \$15,379.50 for a single return and \$30,759 for a joint return.
- Those born between 1953 and 1958 who are 66 years of age or younger: You are not eligible for a deduction under the Income Tax Act of 1967 but do qualify under Public Act (PA) 4 of 2023 to deduct up to 25% of the maximum amount of the allowable deduction for those born in 1945 or before, which for the 2023 tax year equals \$15,379.50 for a single return and \$30,759 for a joint return.
- Those born in 1959 and after Are not eligible for a deduction in the 2023 tax year.

expect with your 2024 Priority Health plan for Michigan Public School retirees. As we might expect there are some increases.

Medicare benefit changes for 2024:

- In-network deductible increased to \$550
- In-network Maximum out-of-pocket increased to \$2,500
- Primary Care Physician visit copay decreased to \$0
- Pulmonary rehabilitation and supervised exercise therapy – decreased to \$15
- Routine chiropractic visits, with no visit limit during the plan year and only a \$10 copay

Pre-Medicare members' benefit changes for 2024:

 Priority Health is happy to report that there are NO benefit changes

Extra health benefits included in your plan, designed to help you be your healthiest:

- For Medicare members, the Silver Sneakers program gives you access to gym memberships.

Online Fall 2023 Retiree Healthcare Plan Seminars

These Seminars, which I strongly recommend that you view, will be held October 10 through December 15, 2023. Benefits covered are Blue Cross (Medicare and non-Medicare), Optum RX, Eye Med, and Delta Dental.

Synopsis of Major Changes from Seminars (but not all-inclusive)

A new service this year is the 24-hour nurse hotline 800-775-2583

If you are looking for a new primary provider and are on Medicare, call 800-810-2583 or online bcbsm.com/find-a-doctor. Non-Medicare call 800-422-9146 (8:30–5 M–F) or online bcbsm.com/find-a-doctor.

As of January 1, 2024, non-Medicare members will have their vaccines covered.

For all members–Emergency room copay will be increased to \$135 per visit. Copay will continue to be waived if admitted to the hospital within 72 hours. For non-Medicare members, the copay continues to apply after you meet your coinsurance maximum for the year. Until the maximum is met,

10% coinsurance and deductible apply.

For non-Medicare, the following preventive screenings will be covered in full: mammogram, pap test and pelvic exam, prostate



cancer screening, and screening colonoscopy.

Retail health clinics will be a covered place of service.

TruHearing (TruHearing.com/mpsers 855-205-6305)

There are no new changes

Optum RX:

For all members: the 10% additional coinsurance will no longer apply when purchasing a 31-day supply of a maintenance medication at a retail pharmacy.

Non-Medicare members–90-day supplies will be covered at a retail pharmacy

Eye Med

For some members, the eye exam is covered by their medical plan due to the presence of other medical conditions that may affect the eyes, so only the refraction part of the exam is covered by the vision benefit. For this refraction only innetwork service, members need to file a request for reimbursement. (Providers submit claims for all other in-network services.) Even though it is reimbursed as an in-network benefit (up to \$40) you must use the "out-of-network claim form" to submit online or via mail. Include the receipt for your initial exam and the Explanation of Benefits (EOB) that shows the refraction part of the exam was not covered by the medical plan.

Eye exams, new lenses (or contact lenses), and frames will be covered every 12 months instead of every 24 months.

Delta Dental:

Occlusal guards will be covered once every five years instead of once in a lifetime

Posterior composite fillings (white fillings on the back teeth) will be covered as a standard benefit.

Non-Participating Dentists and Reimbursement

If your dentist does not participate with Delta Dental you will be reimbursed at the Premier Dentist level. You must do the following for reimbursement: Log in to the Member Portal or create a free account at www.memberportal.com. Visit the "Claims" section found at the top of your screen. Select "Download Dental Claim Form." Instructions for completing and submitting the claim can be found on pages two and three of the documents.

Vaccines Covered by Medicare Part D (Other than Shingles Vaccine)

- RSV–respiratory syncytial virus (can cause severe infections, especially for those who are immune compromised)
- DT-diphtheria tetanus
- DTP-diphtheria, tetanus, pertussis
- Hepatitis A and B, flu, Covid 19 and pneumonia



The Continuing "Saga" Diabetic Shoes and Inserts

A foot exam **has** to be done by an M.D. or D.O. The M.D. or D.O. cannot "sign off" for diabetic foot exams done by PAs or NPs. The process this year has been made more difficult by Medicare. Make sure that you get forms from the service provider before seeing the M.D. or D.O. who is doing your foot exam.

Volunteer Opportunities

A continuing problem since the COVID shutdown, many organizations have a shortage of volunteers to serve their members. Here are two opportunities for service.

Shepherd's Center Transportation

Imagine you can't drive anymore but have medical appointments you need to get to. None of your friends drive and your family members work during the day. These are situations Shepherd's Center volunteers understand. They provide transportation for people aged 60 and over to medical appointments within Kalamazoo County. The riders must be independently mobile or use a walker or cane; volunteer drivers can't transport people in wheelchairs. Drivers offer their time, car, and gas. Destinations include physical therapy, eye care, dental care, counseling, x-rays, and many types of doctor's appointments. By providing this service, the Shepherd's Center helps people remain in their homes longer and maintain their independence.

Current drivers include people who have worked as a home care provider, scientist, social workers, teacher, postal worker, non-profit director, dentist, researcher, and customer service representative. One driver says, "It is truly a privilege to be a driver for the Shepherd's Center...serving and helping other people is a wonderful way to use one's time during the retirement years. People who we drive often say what a blessing we are in their lives. I would say...that it is a blessing to be able to help them."

All drivers complete an application that asks for two references. The office reviews their driving record, confirms they have current auto insurance, does state and national criminal background checks, and the Executive Director interviews them. The safety of the riders and drivers is important.

You must know that I'm fired up for scholarships and so proud of our organization for helping many students and families financially handle college. Can you hear a plea coming? First, let me do the teacher thing by telling you about the four types of scholarships that we give.

To begin, we have two **honorary scholarships** on behalf of individuals who enriched our organization in immeasurable ways. Currently, that includes the Sally Swanson Health Education Scholarship and the Judy Kucera Education Scholarship.

The second type is **general membership scholarships**. These scholarships are funded from our monthly contributions and are given to a wide range of outstanding candidates. These make up the greatest number of our current ten \$1,500. scholarships.

The third type of scholarship is a **personally funded scholarship**. These are scholarships that are solely funded by individuals in their names. The scholarship benefactor chooses the field of study they want to support and, generally, they select their recipient. Currently, we have the Joann Lynch Public Service Scholarship, the Julie Devers Public Health/ Trades Scholarship, and the James and Sally Roach Fine Arts Scholarship.

The fourth type of scholarship is the **legacy scholarship**. At this current time, we have no legacy scholarship donors. These scholarships are given in memory of a friend or family member. The benefactor solely funds this scholarship, chooses the field of study, and can select their recipient. The scholarship is named in honor of an individual.

At this time, I want to put out a call for personally funded scholarships and legacy scholarships. These scholarships would make it possible for our organization to reach beyond what we can monthly generate and help even more than we do. Our daughter was a recipient of a legacy scholarship from a family that lost their daughter to cancer. In her memory, they looked for a recipient following down the path of their daughter's interests. In our case, it was music. When our daughter was chosen for the family's legacy scholarship, it was an honor. Our daughter knew that she represented a girl and her family and it really touched her soul and, as her parents, my husband and I were honored also.



Remember MARSP/KARSP is your **voice** in Lansing. You need not attend luncheons or be particularly active, but your **membership is important** for lobbying for **pension concerns and health benefits**.
